Planning Commission Meeting Minutes September 25, 2023 Page One

The Town of Orange Planning Commission held a meeting at 6:00 p.m., in the Town of Orange Community Meeting Room. Planning Commission members present were: Chairman Benjamin Sherman, Vice-Chair Page Sullenberger, Commissioners Rita Carroll, Donald Schafer and L.J. Taylor. Staff members present were Director of Community Development John Cooley, AICP, CZA, Town Attorney Catherine Lea, and Deputy Town Clerk Kimberly Strawser, CZA, CMC. Mayor Roby was absent.

CALL TO ORDER

Chairman Sherman called the meeting to order. The Deputy Town Clerk called roll and noted that there was a quorum present.

PLANNING COMMISSION MEETING MINUTES OF AUGUST 28, 2023

The Town Attorney appeared before the Commission to report that at the last meeting the Director of Community Development ran the meeting, since the Chairman and Vice-Chair that were re-elected, but absent from the meeting. The Town Attorney recommended that the minutes from June 26, 2023, be reconsidered since the Director of Community Development cannot sign the minutes.




