A motion was made by Dr. Jennings, seconded by Vice-Chairman Mason, to adopt the meeting minutes of July 19, 2023, as presented. On vote, Chairman Higginbotham — absent, Vice-Chairman Mason — aye, Mrs. Amos — aye, Dr. Jennings — aye, Mr. Reynolds — aye, Mr. Rutt — aye and Mr. Sylvia — absent. The motion carried.

## TREASURER'S REPORT

The Town Manager reported that there were no change in funds since the last meeting. The Town Manager asked the Director of Finance/Treasurer to report of the balance of funds. The Treasurer reported that the balance was \$153,457. A discussion was held regarding funds being in an interest-bearing account.

On vote, Chairman Higginbotham — absent, Vice-Chairman Mason — aye, Mrs. Amos — aye, Dr. Jennings — aye, Mr. Reynolds — aye, Mr. Rutt — aye and Mr. Sylvia — absent. The motion carried.

## CONTINUED DISCUSSION OF IDA DIRECTION - DISCUSSION OF IDA FUNDS

Members of the IDA asked if town staff would do some research on how to attract new businesses to town. The following suggested business to look into:

- Mini Walmart
- Lidl
- Kohls
- Germanna or Piedmont satellite classrooms
- Entertainment
- Bowling alley

Mr. Rutt reported he spoke to the Sedwicks to get an update on Sean Gregs office space on Main Street. Mr. Rutt reported further that the Sedwicks already had two people interested in the space, one being a bakery and the other was unknown.

Mrs. Amos discussed marketing ideas that she and Vice Chairman Mason discussed. After discussion it was decided that the IDA would join the Chamber of Commerce, that the IDA page on the town's website would include their Mission Statement, rules/guidelines, and the FIG application and that the IDA put together a brochure of what they can offer to businesses.
