## REVIEW AND DISCUSSION FOR PROPOSAL OF 23 LOTS AT 11455 RAPIDAN ROAD

Mr. Christopher Hemp of 1216 Emily Ln., Richmond, Virginia appeared before the Commission to discuss his proposal at 11455 Rapidan Road called Selma Estates. Mr. Hemp stated that the property is 6.35 acres and he is proposing a 23 lot subdivision. Mr. Hemp stated further that this development would provide smaller lots with downsized housing. Mr. Hemp stated that this type of development would allow easier maintenance for senior residents.

The Director of Community Development stated that tonight's discussion is an extremely preliminary review of the information submitted by Mr. Hemp, as well as a very quick review of Town Code and what may be required for this type of development. The Director of Community Development then said he would very quickly go over the preliminary site data, including that the zoning is Rural Residential, the land use restricted to single family dwelling, and the tract is 6.35 acres. The Director of Community Development stated that he had met with Mr. Hemp and discussed the preliminary proposal but had not received a subdivision application as of yet. The Director of Community Development stated that since this is a preliminary discussion other agency reviews have not been done at this time. The Director of Community Development stated that currently 9 lots could be done on this parcel by right without a public hearing. Clustering of nine lots would also not require a public hearing;

however clustering requirements are not "spelled" out in the Town's zoning ordinance. The Director of Community Development reported that the Town does allow clustering but how to move forward would need to be discussed further with applicant. The Director of Community Development stated that staff had received 4 letters of support of the proposed subdivision and numerous telephone calls in opposition.

There was discussion by the Commission members, including questions of whether the proposed road would meet VDOT standards and whether the lots would be restricted to sales to the elderly (Mr. Hemp replied that they would not). After discussion, Chairman Sherman stated that the Director of Community Development and Mr. Hemp would discuss the next step of action and bring it back to the Commission.
