The Director of Community Development stated that staff updated CIP to included Public Works – Equipment, Marshall Heights standpipe & repair and road reconstruction projects.

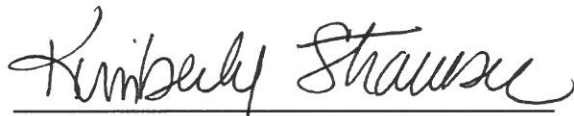

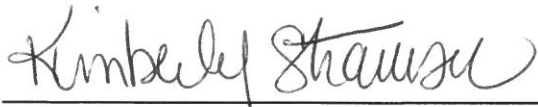

PUBLIC HEARING – PLANNING COMMISSION HELD A PUBLIC HEARING ON TEXT AMENDMENTS TO CHAPTER 19, ARTICLE 11 – SIGN REGULATIONS & ARTICLE 14 DEFINITIONS – 14-20.263 THRU 14-20.325 OF THE TOWN OF ORANGE ZONING ORDINANCE

Chairman Sherman called for presentation. The Director of Community Development gave an update of the proposed updates.

Chairman Sherman declared the public hearing open and called for public comment.

There being no public comment Chairman Sherman declared the public hearing closed.

Chairman Sherman called for questions/comments (if any) from the Commission.

After discussion, motion was made by Commissioner Schafer, seconded by Vice-Chair Sullenberger to recommend to Town Council the updates to the Town of Orange Zoning Ordinance, Chapter 19, Article 11 – Sign regulations as presented. In addition the Commission recommends that Town Council repeal all sign related definitions in Article 14 – 14-20.263 thru 14-20.325 and include on entry for Signs – *for sign related definitions see Article 11*. Lastly, the Commission recommends that Town Council remove in its entirety Chapter 54 – Signs, found in the Code of Town of Orange, Virginia. On vote, Chairman Sherman – aye, Vice-Chair Sullenberger – aye, Commissioner Bosford – absent, Commissioner Lovell – aye, and Commissioner Schafer – aye. Motion carried unanimously.

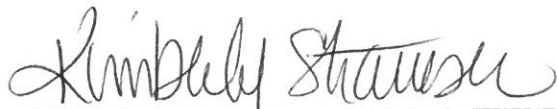

The Deputy Town Clerk stated the next meeting would March 26, 2018 at 7p.m. and the public hearing for the Capital Improvements plan would be on that agenda.

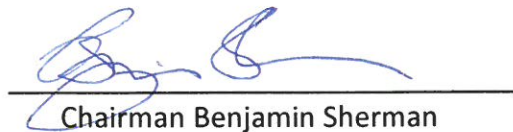
UPDATES

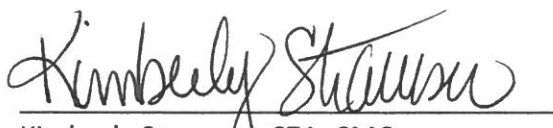

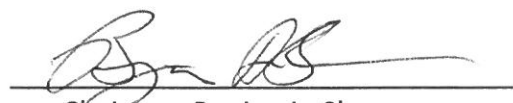
NEXT MEETING

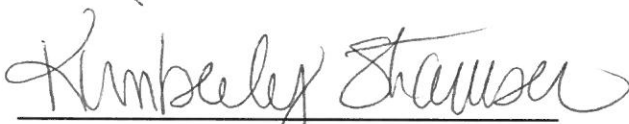
