# Theme 11: Recreation

### Mission

Similar to the arts, recreational amenities rank high on the list of contributors to a community's quality of life. Parks and greenways will be integrated throughout the Town and into the County within walking distance of every Planning Sector. Within minutes of leaving their homes, children and families will be able to access the system to walk or ride to traditional recreational facilities such as ball fields and courts, and to non-traditional activities such as hiking/biking and nature trails. We will foster the private and public development of these recreational resources through new public-private partnerships. These partnerships will explore development of these opportunities where they do not presently exist and enhancement of them where they do.

## Background

The Town of Orange maintains three parks in Town; Taylor Park and Hazel Sedwick Park in Main Street, and Belleview Park. Other than these parks in Town, recreational services are provided by the County. These services include:

- Field and court sports, including youth football, basketball, and soccer.
- Dix Memorial Pool in Gordonsville
- Sport parks in each district of the county
- Before and after school daycare programs
- Hornets Sports Center at the Orange County High School.
- Library services at the Sedwick Building

Pressure on the Town to increase recreational services will likely increase in the coming years as the Town learns to market its Quality of Life to small and medium information and technology companies in Northern Virginia (see Theme 1: Economy).

Goal R1: Quantify existing and planned recreation quality of life.

Concept Map that shows existing recreational areas and other areas that may be redeveloped or developed that have sufficient acreage to be a potential candidate for development of a field or play area. Locations of these areas are approximate and may be better located on another portion of the parcel or on another parcel(s) entirely. It should be noted that these areas are not a "future land use" category.

Goal R4: Create active outdoor recreational opportunities.

Action R4.1: Complete greenbelt joint feasibility study.





Figure 25: North Greenbelt

Analysis: "Greenbelts" are boundaries surrounding a town or city that provides recreational opportunity for hiking and biking and serves as a long-term boundary between urban and rural land uses. Proposed in this Plan is a cooperative Town-County greenbelt to serve residents in the western portion of the county and along its length might intersect a future camping area (such as Walnut Creek, developed by Albemarle County, south of Charlottesville) and a future wellness center (see below). It is anticipated that the greenbelt would be constructed in phases identified in the Feasibility Study. Cost and funding sources would also be included in the study. Figures 25 and 26 below show "concept" alignments for the greenbelt as a light green line.



Analysis: Wellness facilities such as Atlantic Coast Athletic Club (ACAC) in Charlottesville, provide multiple benefits to the residents and businesses of a community. A wellness complex could serve the following functions:

- Indoor/outdoor Olympic swimming complex
- Fields and courts
- Training and sports medical facilities
- Hub for active and passive recreation, including hiking, biking, and birding

Goal R8: Create expanded recreational opportunities for citizens and businesses in the Town and County.

Action R8.1: Create a Comprehensive Recreational Facility in the area around Orange County High School and Chatter Island.

#### Analysis:

The Orange County Parks and Recreation Department has been considering the construction of an indoor public pool for several years. The pool is needed to serve students in the Orange County Public School system. In addition, the track at the high school is a substandard facility, in need of extensive renovation, including a modern rubberized surface, and fence. There is also a need for a skateboarding facility somewhere in Town. Skateboarding has become the largest club at the high school. The Town and County should also work together to find a recreational use for Chatter Island and integrate the use through walking and hiking trails to sports facilities at the high school.

People today are disconnected to rivers. In my time, everyone went to the river to swim and fish. Who goes today? You can't get to it. The Rapidan has become a forgotten asset to most Town residents, for anything other than drinking water.
